Paul LeBlanc shared a power point presentation with details on the proposed UDO.

Following the presentation Tim Gaylor came forward explaining he is a general contractor who has resided in Richmond Hill since 1999 and currently works in Richmond Hill, Bryan County, Chatham County, and Liberty County. Mr. Gaylor stated he feels the preliminary planning requirements are clearly outlined and the UDO will be helpful. He ended by stating he is in full support of the UDO.

Commission Baraniak asked Mr. Gaylor if Bryan County has discussed doing something similar to the UDO and he replied he was not sure.
